RE: Data Request for StarKist Pacific Ocean Longline Tuna Fishery Improvement Project Vessels

Dear Lucy, Jeyalda and Tony,

The submission of this letter is a formal request for data pertaining to Vanuatu flagged vessels included in the Fishery Improvement (FIP) Pacific Ocean Longline Tuna Fishery (StarKist). The data request is made on behalf of the vessels in **Table 1**.

The fishery targets albacore (*Thunnus alalunga*) and catches bigeye (*T. obesus*) and yellowfin (*T. albacares*). The pelagic longline vessels are flagged to Taiwan, China, Federated States of Micronesia (FSM), Vanuatu, Cook Islands, Fiji, American Samoa, Samoa, French Polynesia and Panama and fish on the high seas in the Pacific. The fishery is managed regionally by the WCPFC and by the IATTC.

This FIP aims to meet the rising global demand for tuna in a sustainable manner by assuring catches do not exceed sustainable levels, promoting the ecosystem-based approach to fisheries management and strengthening policy and governance systems in the region. The end goal is to achieve certification under the Marine Stewardship Council Fisheries Standard by 2025.

Currently to meet many of these aims, vessel catch, and operational data is required. Although the vessels within the FIP collect catch statistics, they are currently not sufficient in their scope and depth (species classifications, volumes etc.) to address many aims of the FIP - such as understanding the impacts of the fishery on non-target and endangered, threatened and protected (ETP) species. This data will be used for this fishery to achieve MSC certification.

As one of the governing authorities we are writing to you to please help us with the acquiring of this data. If we are taking the wrong way about submission for this request, it would be appreciated if you could direct us to the appropriate mechanisms/channels.

Data request

In line with the Rules and Procedures for the Protection, Access to, and Dissemination of Data Compiled by the Commission (as revised by WCPFC4 2007), on behalf of vessel owners, we please request <u>observer catch data for, if possible, the past 5 years (understanding the impacts COVID had on observer coverage) for the longline vessels in this StarKist Pacific Ocean Longline Tuna Fishery.</u>

This data will go towards helping to adopt an ecosystem-based approach to the FIPs management plans. Please see **Table 1** for vessel name, IMO and flag state. If possible, information such as the below would be beneficial:

- Number of sets
- Fishing locations of sets
- Type of set (floating object or free school)
- Bycatch information, such as species, fate and condition if released
- FAD deployment information
- Estimate of weight (or number of individuals) caught of ETP species
