Subject & Aim

“**SUSTAINHOOK**” is an ambitious communication program to disseminate the work carried out by FIP BLUES promoters, aiming at communicating to all stakeholders not only the work of the FIP but also health and quality aspects concerning fish consumption, fisheries governance, fishery sustainability, etc. It represents **a key component of the strategy to disseminate the FIP activities** and reach relevant stakeholders related to fisheries management and markets at national and international level.

As part of the communication strategy FIP Blues continued by organizing this second international event in Vigo Port Authorities headquarters. Besides, after the seminar the partners launched the new campaign called “**TINTORERA Y PEZ ESPADA SOSTENIBLE de pesca gallega**”, which is explained in detail the next sheet.

This mixed webinar was released to a diverse audience of stakeholders (private and public), either present or in streaming emission: public authorities, technical and scientific staff, marketers, NGOs, etc. The event counted with an attendance mixed attendance in situ and online. Attendees ranged from governmental to non-governmental actors, relevant scientists, private companies, etc.



First, it took place the presentation of the event and the intervention of maritime and fisheries affairs public authorities from Galicia, Spain and Portugal (<https://fipblues.com/en/webinar-december-2021>) .

The Webinar was structured into four sections (see attached Agenda Sustainhook_1 Dec 2021): In the first section representatives from the Galician, Spanish and Portuguese sea and environment affairs departments made their respective presentations and participated in the final debate with one section focused exclusively on the presentation of FIP Blues action plan. These blocks included also the participation of representatives/professionals from NGO (Sustainable Fisheries Partnership), experts in nutrition-health from the public national health system and a researcher from the university.

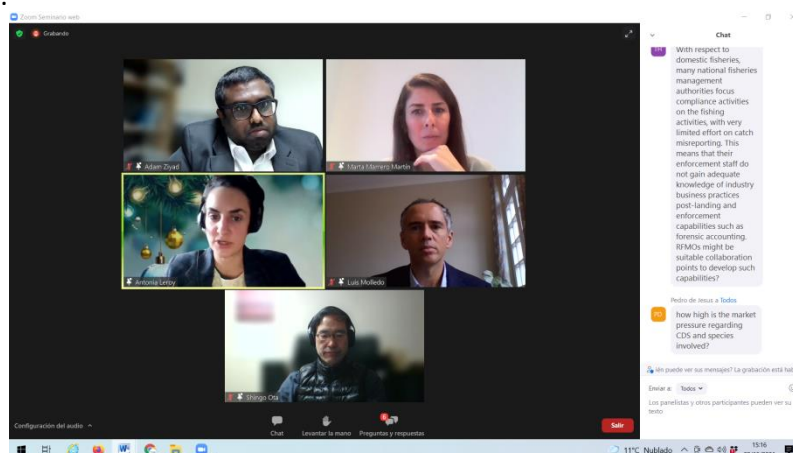
Attendance to “Seafood traceability: aligning RFMO CDS to combat IUU fishing”. 09 December 2021

Subject & Aim

By attending these conferences FIPBLUES aims at increasing participation in international forums as well increasing knowledge in relation to current debates on IUU fishing versus responsible and sustainable fisheries management.

In this event “the EU IUU Fishing Coalition held an online event, with over 120 participants, to launch its new study on aligning Catch Documentation Schemes –CDS- in RFMOs to combat IUU fishing”.

It dealt with the current lack of harmonisation between CDS regimes across RFMOs, as well as their lack of compatibility with two major import regimes (the U.S. system, SIMP, and the EU catch certificate) and at the time highlighted the limitations in the voluntary UN Food and Agriculture Organization’s (FAO) guidelines for CDS.



Results/Outcome

Attending this type of technical events FIP Blues technical team gains first-hand knowledge about the numerous efforts being made to build sustainable seafood systems and gives useful insights in a number of issues related to the FIP social implementation.

Activity/task:

Publication of an article about mako in a Spanish international magazine specialized in fisheries.

Subject & Aim

As part of the dissemination activities of FIP BLUES and also as part of our willing of collaboration and commitment with fisheries sustainability, Emilio Martínez Cadilla (President of Anecteam) published an article in an specialized magazine about the situation of the short fin mako fishery in ICCAT and effect in the fleet: "Measures for all on establishing a fair play ground for all operators of mako at international level".

He deals with the last measure for short fin mako in the North Atlantic and the need for a fair play ground for all operators as the Spanish FIP Blues fleet has complied with all measures either at national, European (EU) and international (ICCAT) to lead the stock to sustainable levels, while it is argued is not the case for all operators in ICCAT waters.

In his opinion, this has resulted in an unjust situation for the fleet compared to other fleets, which apparently have not the same strict measures as the European ones. Obviously, that has an impact at economic, social and environmental level.

In addition, a Emilio Martinez asserted the commitment of the sector with the sustainability of the fishery through the challenging FIP BLUES currently in implementation, which means collaboration with public managers (state, EU, ICCAT) scientist and NGOs, among others, in favour of transparency.

Therefore, a clear, equal and fair play ground for all operators of mako at international level is demanded for the conservation and sustainable use of that species, which, although in small percentage, is part of the catches of the fleet (now limited to the South Atlantic).

Results/Outcome

- An article to add to the communication and dissemination strategy in sector scenes.
- Express the willing of the fleet to comply with the measures but claim for an equal requirement for all operators: support of the responsible role of the fleet and the actors of the supply chain involved.
- Demonstration of transparency as principle and a practice of FIPBLUES.
- Regional, national and international stakeholders learnt a valuable opinion from the industry.

09-11 February 2022 (on line).

Subject & Aim

It is an international event organised as part of the “One Planet Summit” which has been dedicated to the protection of oceans. This 3-day high level event was organised in the context of the French presidency of the Council of the European Union, with the support of the United Nations and the World Bank, in the presence of about 30 foreign leaders and international organisations, business leaders and policymakers from the civil society. The One Ocean Summit has defined priorities to translate into actions a shared responsibility on the ocean.

By attending these conferences FIPBLUES the project continues to gather knowledge about the international initiatives focused on the ocean protection, including sustainable fisheries management. In fact, one of the Areas of priority of the event was “preserve the ocean resources through the promotion of sustainable fishing and the fight against illegal fishing, with the ratification of new agreements” ([Brest Commitments for the Oceans](#)).

As we are part of the EU, CPC in ICCAT, it is worth to highlight the ambitious initiatives presented by the EU Commission to promote a cleaner, healthier and safer ocean, as part of the EU's contribution to the One Ocean Summit and a demonstration of EU's leading role in bringing a comprehensive response to oceans challenges. In fact, President Von der Leyen announced three key initiatives for cooperation to preserve and revive the oceans: a new international coalition to protect biodiversity on high seas, which constitute 95% of the ocean; a major computing project allowing researchers to digitally simulate the world's oceans; and the EU's research mission to restore our ocean and waters by 2030. Interview of FIPBLUES representatives in the TV program “Bos días” of the TVG (Televisión de Galicia; the public Galician Television channel).

Subject & Aim

As part of the communication strategy and the will to explain all the aspects related to the fishery that have an influence in the industry Juana Parada (ORPAGU) and Emilio Martínez (Anecteam) attended an interview in the news program “Bos Días” from the TVG, the main TV channel in Galicia.

Due to the complex situation caused to the industry because of the delay of the MITECO in providing permissions to sell the annual short fin mako –s.f mako- catches (except for north Atlantic) according to CITES criteria the industry claimed for a more resolute and fair decision with that regards. They talked about the prejudice caused to the fleet, the regulated-controlled condition of the fishery, the management and regulations affecting it, the political-administrative level, the compliance of the fleet with all regulations (national, EU, ICCAT), and the need for a fair play ground for all operators, etc.

Therefore, after having analysed the context and exposed their arguments, they claimed for the lead role and commitment with fisheries sustainability of the industry. They highlighted the effort that the fleet is making in order to improve its performance as stated in the FIP action plan.



Results/Outcome

- A new task implemented as part of the communication strategy.
- Demonstration of transparency publicly exposed.
- The view and the opinion of the industry are spread to a relatively high share of TV audience.
- Transparency is shown as a characteristic of FIPBLUES as principle and a practice.

Changes to the MSC standard. Marine Stewardship Council.

Subject & Aim

MSC organised two webinars to explain the work done and the next steps to change some key criteria of the MSC standard. As FIP is based on the MSC methodology we attended this relevant webinar to inform those changes and how it could affect the implementation of our FIP.

The first Webinar focused on "Introducing the Proposed Revised MSC Fisheries Standard with a focus on preventing shark finning, harvest strategies and evidence requirements" by the Fisheries Standard Director, Ernesto Jardim.

This is a key topic for FIPBLUES as our fleet does not make finning (and besides it is prohibited by law in EU). Therefore, FIPBLUES welcomes that MSC includes now the ban of shark finning, something our fleet has claimed/is claiming for in ICCAT and other arenas to be compulsory in all RFMO as stated in the Action Plan (mainly in Action 2).

The second Webinar presented "Introducing the Proposed Revised MSC Fisheries Standard with a focus on endangered, threatened and protected species, preventing gear loss and ghost fishing, and making our standard more efficient", by Chief Science and Standards Officer, Rohan Currey. Again, that's a relevant topic we are dealing with in Action 2.

In summary, the objectives of this review are:

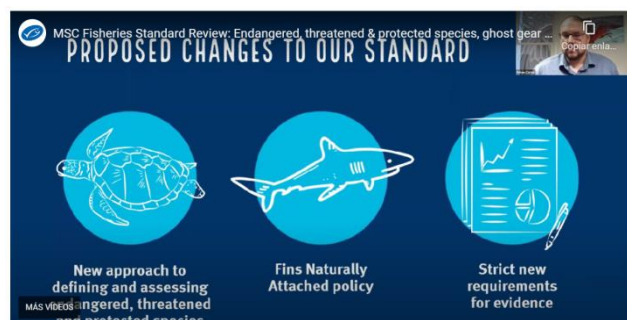
- Making the standard more efficient including better scientific understanding and fishery management practices in the Standard.
- To make the Standard clearer for those using it in fishery assessments.
- To make the Standard less complex and remove barriers to fisheries joining and staying in the program.
- To make the Standard more accessible to fisheries in the Global South and make it more applicable to high priority species and ecosystems.
- To improve data collection and evidence-based decision-making.

The proposed changes focus on:

- Working with mixed fisheries
- New approach to defining and assessing Endangered, threatened, and protected species
- To ensuring shark finning does not take place in MSC certified fisheries.
- Strict new requirements for evidence
- Minimising fishing impacts on ecosystems and habitats: clearer and more consistent assessment of habitats and ecosystems
- Preventing lost and abandoned fishing gear (ghost fishing)
- Improvements to Risk-based framework

Subject & Aim

Aiming at increasing participation in international forums as well increasing knowledge in relation to current debates on ocean's resources, responsible seafood and sustainable fisheries management, which is directly linked also to the FIP social implementation.

The three-day event [4th Oceans Forum on Trade-related aspects of SDG 14](#) addressed "The ocean's resources sustain the livelihoods of about 3 billion people worldwide, the vast majority of whom live in developing countries. But those livelihoods are under threat, as the ocean and its ability to sustain life are in grave danger due to human activities, such as pollution and overfishing. Every year, an estimated 5 to 12 million metric tonnes of plastic flow into the ocean, which represents 95% of our planet's biosphere. And due to overfishing, the percentage of fish stocks within biologically sustainable levels fell from 90% in 1990 to less than 66% in 2017. The 4th Oceans Forum, to be held from 6 to 8 April 2022, is a unique platform to identify ways to change course.

It's an opportunity to find solutions for using trade as a tool to protect our ocean and its resources, accelerating the implementation of Sustainable Development Goal 14's trade-related targets".

Among others, there were topics of interest for FIPBlues, like:

- Transparency and implementation mechanisms to support fish subsidies and non-tariff measures (NTMs) reform
- Sustainable and resilient maritime supply chains
- The Maritime Supply Chain Crisis.
- Moving way from unsustainable government support to fisheries An OECD perspective
- Sostenibilidad Social de la Cadena de Valor de la Pesca y la Acuicultura

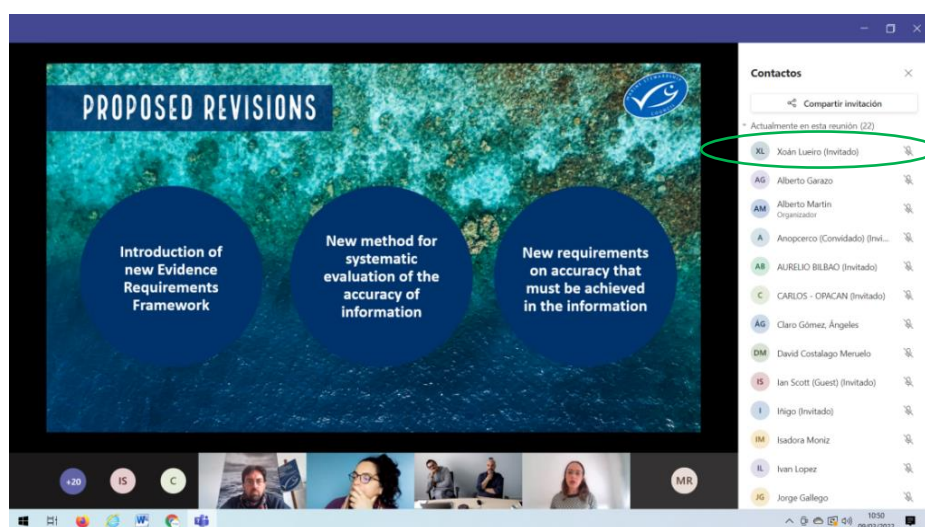

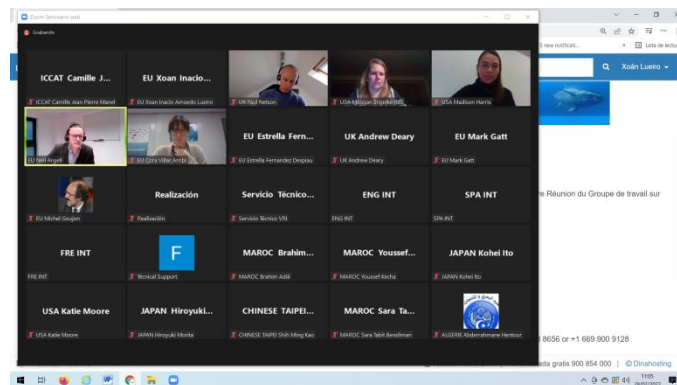
Activity/task:

Attendance to "1st Meeting of the Electronic Monitoring Systems (EMS) Working Group. SCRS. ICCAT" (Virtual meeting, 28.02.2022).

Subject & Aim

As part of Action 1 tasks to increase presence and interaction with ICCAT (SCRS working groups) FIP Blues attended this technical meeting aimed at developing EMS standards. This way FIPBLUES continues to be present in those discussions whose topics are directly linked to the actions we develop in the FIP.

It was the first meeting of this Working Group in order to discuss the technical and administrative basis for EMS after the suggestions that came out from the past 27th Regular meeting in 2021 and previous working groups meetings dealing with the topic. However, in 2021 there were no specific Recommendations from the SCRS on longline or other fisheries.



At the present Subgroup main work is focused on:

- Data fields: comparison of what can be obtained with human observers versus EMS (using ST-09 data forms);
- Vessel adaptations/camera location: any adaptations that may be needed for EMS to collect needed data.
- Propose **minimum standards** (mostly focusing on the technical aspects, such as n° and location of cameras, etc)

Main ideas of the discussion:

- EM systems cannot substitute for a human observer so they are likely to be used as a complement rather than a replacement at-sea observer programs. EMS is supplementary to physical observation and never a substitute.
- EM systems need to address the **challenges associated with processing and analyzing very large volumes of data that will result**, which are different to the challenges encountered when dealing with human observers and their data.
- It is possible that future **improvements in artificial intelligence, machine learning/deep learning algorithms**, hardware and software can mitigate some of the current limitations with data collection and analysis
- Integrated EM systems must be able to **meet both national and international requirements to ensure data collection, continuity, veracity and precision** are not compromised **and that scientists have the required data to ensure they can continue to provide accurate scientific advice to managers**.
- Need for a **separation of scientific vs compliance objectives/data in terms of the EM Systems**, noting that many EM systems to date have been implemented mainly for compliance or mixed purposes.

The Subgroup agreed that for scientific purposes, it is important to assure that EM systems can record and collect needed scientific data (e.g., species ID, sizes, sex on elasmobranchs, discards, etc) and not only compliance data, although they recognize that collection of **some type of data seems to be more difficult at present**.

On-going work in 2022 of the EMS WG:

- Continue the work and present the final recommendations to the SCRS in 2022.

- Aim to finalize work on: T-09 form data fields and Technical specifications of minimum standards (nº of cameras and location, etc).
- Provide any requested updates on the status of the work to PWG and receive feedback (and now to this EMS Working Group).
- The final recommendations from the Subgroup will be presented to the SCRS/SC-STATS in September 2022.

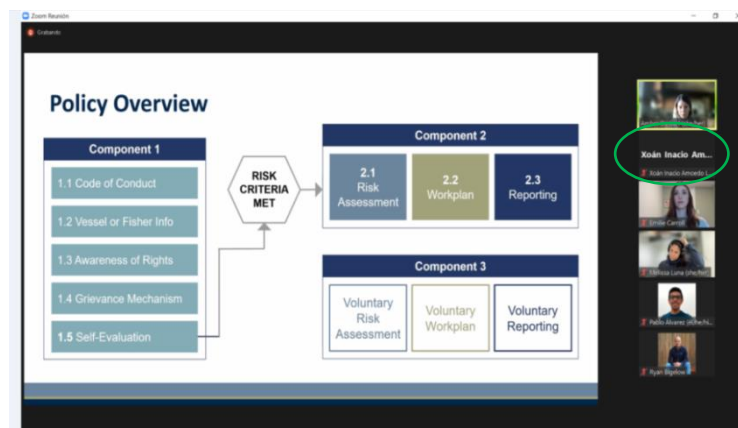

Meeting with the responsible of the Spanish MITECO to deal with the situation of mako commerce and the certificate CITES.

Subject & Aim

MITECO: Ministerio para la Transición Ecológica y el Reto Demográfico.

MAPA: Ministerio de Agricultura, Pesca y Alimentación.

OPPs: Organización de Productores Pesqueros (fishing associations).

The manager of the four OPPs (fishing associations) of FIP BLUES met with representatives of MITECO in order to deal with the situation of mako in Spain owing to the lack of agreement between the MAPA and the MITECO: it is allowed to retain short fin mako until certain catch level established by the RFOs (except for the North Atlantic) and applied by the MAPA as fisheries administration in Spain.



But, there seems to be an understanding on the part of the MITECO regarding how to administer CITES Appendix II certificate to allow the regulated/controlled trade of this specie and so it is not issuing the necessary certificates to sell the fish. Therefore, the OPPS complained for the economic prejudices arising from the paradoxical situation between the ministries. They claimed for a solution and clear certification to be able to sell the fish. Apart of this meeting there have several previous communications and talks with those state administrations and also with the Galician fisheries department (https://www.xunta.gal/notas-de-prensa/-/nova/66848/galicia-urge-gobierno-central-una-solucion-bloqueo-comercializacion-las-capturas?langId=es_ES). Among other arguments, when meeting with authorities, the OPPs asserted the FIPBLUES the commitment with fishing and commerce sustainability that suppose.

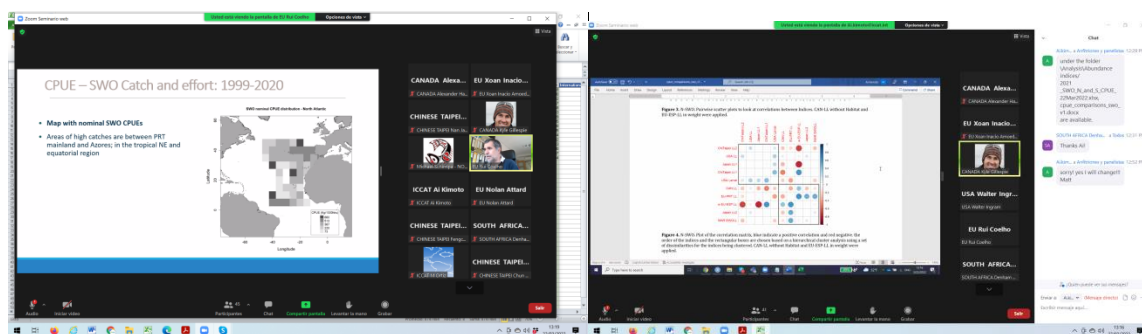
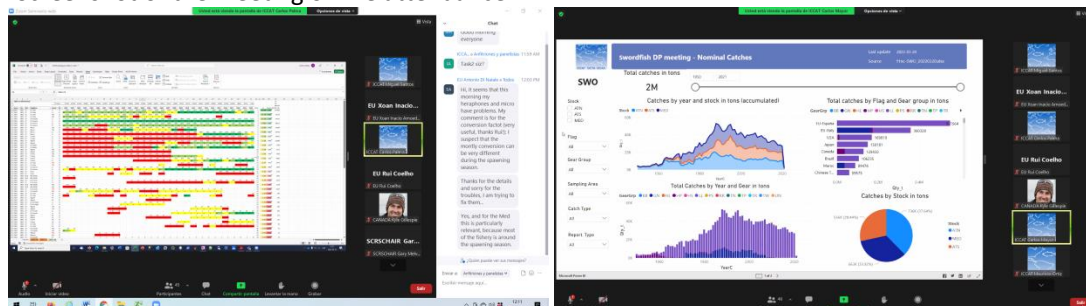

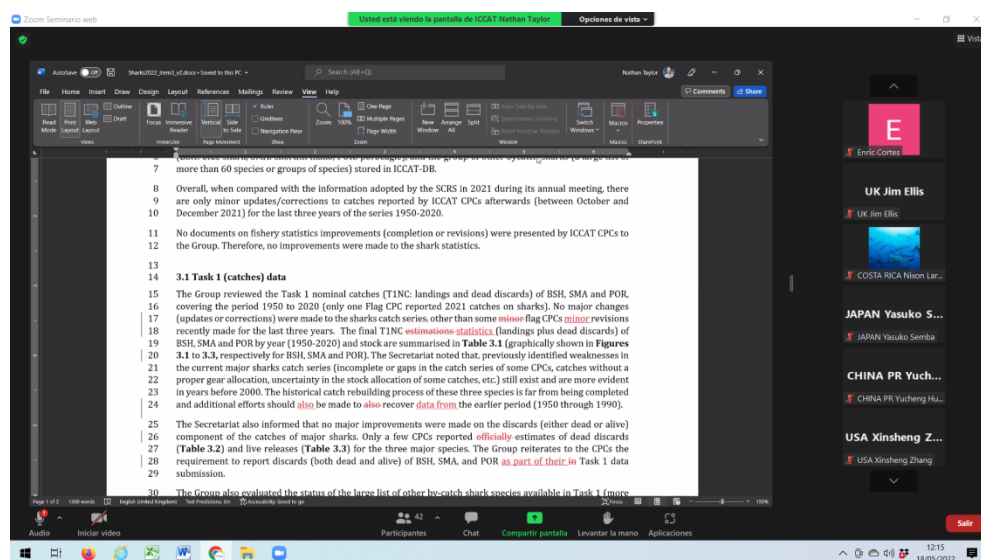
