Update progress:

- 1. For the first time, we met directly with Bu Agustiana (Lecturer from University of Lambung Mangkurat South Kalimantan) and her staff. We discussed about action plan and University's role on this action plan. Bu Agustiana and team are fully support on this project.
- 2. Officially Sekar Laut has been registered into ITM (In-transition to MSC). ITM is a progress platform that show our fishery progress toward MSC full assessment. ITM is similar to fisheryprogress.org, but the ITM supervision is directly from MSC itself. And the benefit of joining the ITM program is our fishery will be verified by the independent and verified CAB annually and we can ensure that the implementation of the action plan is measurable.
- 3. Since shrimp fishery registered on Fish for Good program and National FIP, we hope that shrimp commodity become one of priority fishery under MMAF program. The benefit of becoming the priority fisheries is all studies and research would be under MMAF supervision/program directly. (e.g. management fishery, harvest strategy, etc.).
- 4. Considering new regulation related to logbook (Peraturan Menteri Kelautan dan Perikanan No. 33 tahun 2021) for fishing boats under 5GT are required to collect fish catch data through a simplified log book. And the province/local government responsible for collecting this data directly. Going forward, Sekar Laut will share the voluntary log book to government as a reference for them.

Subject : Fisheries Improvement Program (FIP) National Meeting with MMAF/Central Government

Date : December 13 – 15, 2021

Update progress:

- 1. All Indonesian FIP needs to build a strong database of fisheries improvement programs based on digital maps and integrated to the MMAF website. Hopefully all stakeholder who involved in this program are able to access and monitor the progress of each fishery.
- 2. All database, information and scientific studies that have been collected from all FIP's Leads will be used as supporting materials in the preparation of fishery management plans, harvest strategies, and measured fishing policies.
- 3. Involvement and support of local government and other stakeholders in implementing the action plan.
- 4. Related to the MSC assessment, MMAF will focused on performance indicator score below 80.
- 5. Stock statues, biological aspect, ecological research studies, management units, mapping of fishing ground, and spawning/nursery areas will be completed immediately to support management strategies.
- 6. MMAF will encourage Komnas-KAJISKAN (National Research Division) to estimate potential/stock for FIP priority fisheries.
- 7. Difficulties in implementing fisheries improvement programs involving small scale fisheries will be immediately resolved by coordinating with the Provincial/District/City Maritime and Fishery Services, especially with regard to the completeness of fishing vessel documents and supervision in areas according to their authority.
- 8. FIP National meeting will be conducted regularly (twice a year). And this meeting will be held by MMAF.

Next action Plan:

- 1. ETP species socialization to all fishermen in Kotabaru, e.g. sharks and horse shoe crab. How to handle ETP species if fishermen found it during fishing (Principle 2)
- 2. Visit BRPL (Indonesian research Agency, under MMAF supervision) to discuss technically regarding scientific studies for data management, harvest strategies, etc. (Principle 1 and 3)
- 3. Encourage central government/MMAF to conduct socialization immediately regarding simplified logbook for fishing boat under 30 GT to Syahbandar port and fishermen.
- 4. In parallel, we will adopt a new logbook format, and we will try to implement and voluntary ask to fishermen to start refilling the logbook (while waiting for the official logbook implementation from central government)
