In accordance with clause 5.2. The order of the commission's activities, based on the recommendations of the Kamchatka branch of the Federal State Budgetary Scientific Institution "All-Russian Scientific Research Institute of Fisheries and Oceanography", the North-East Territorial Administration of Russian Fisheries and the North-East Branch of the Federal State Budgetary Institution "Main Basin Administration for Fisheries and the Conservation of Aquatic Biological Resources" dated September 14 2020 No.01-15 / 25/75

The resolution is:

- 1.1 To determine the industrial and traditional fishing (communities individuals) prohibition timing for prevention of the massive seizure of Kamchatka salmon in the coast of Western Kamchatka migration routes, as well as due the established volumes of the Pacific salmon predictable catch development and a intensity decrease of coho salmon forthcoming, indicating its spawning run final stage:
 - Since September 16th midnight in the Kronotsky Bay, Avachinsky bay, Avachinskaya lip and the flowing rivers.
 - Since September 16th midnight in the West Kamchatka subzone and the Kamchatka-Kuril subzone and flowing rivers.

By voting: "for" - 12, "against" - 3 (Danilin D.D., Metelitsa A.M., Kopylov A.A.) (Danilin D.D. special opinion is attached).

1.2 To recommend the fishing grounds users to use only fishing rods (spinning rods and fishing rods) as fishing gear for amateur fishing organizing in the Avachinsky Bay, Avachinsky Bay and flowing rivers, the Western Kamchatka subzone, Kamchatka-Kuril subzone from 16th of September to 19th of October for the purpose of coho salmon stocks conservation.

Dear Yury Aleksandrovich!

I would like you to attach my special opinion on issue 1 to Protocol No.30 of September 15, 2020 of the Commission for the Anadromous Fish Species Regulation of the Production (Catch) in the Kamchatka Area. On the completion of industrial and traditional fishing timing in certain fishing areas of the Kamchatka Area.

Firstly, the recommendations of the Federal State Budgetary Scientific Institution "All-Russian Scientific Research Institute of Fisheries and Oceanography" ("KamchatNIRO") justifying earlier dates for the end of the fishery than had been established earlier (before September 28) were not sent out. The verbal comments of the director of KamchatNIRO indicate the reason is "insufficient filling of spawning grounds with coho salmon producers." But it's too far to the end of coho salmon entering the rivers.

I believe that the Commission decision contradicts the strategy of Pacific salmon fishing in the Kamchatka Area in 2020 and cannot be legitimate, since the requirements of paragraph 3 of the Appendix to the Order of the Ministry of Agriculture of Russia dated February 26, 2020 No.86 that the required recommendations for the Commission to make decisions must be submitted no later than one business day before the Commission meeting. It will serve a reason for enterprises that have suffered losses from this decision for going to court. The Industrial enterprises made their plans and calculated costs according to the previous decision. It is necessary to cancel that solution and allow the enterprises to finalize it before the established deadline by the fishing strategy and the previous Commission Protocol (No.27).
