Sustainable Tuna Partnerships Phase 2: Supporting Harvest strategies and control rules in the WCPFC

# **Sub-regional Hybrid meeting Terms of Reference**

#### Background:

With a shared goal of maintaining healthy stocks of tropical tuna, specifically yellowfin tuna, in the WCPO, the Philippines and Indonesia need to reach a consensus on how they can ensure the adoption of HS by 2024. Both countries have much at stake in healthy stocks that provide food and livelihood to millions of SSFs and coastal communities in their archipelagic waters as well as in access to lucrative markets that depend on eco-certifications subject to HS requirements. Furthermore, the Sulu Sulawesi seas that transverse both countries are spawning areas and juvenile tuna feeding grounds thus critical to stock regeneration and health in the region.

Decisions on the adoption of HS at the WCPFC have slowed or stalled due to the Covid global pandemic that deterred face to face meetings and delayed decision making on critical issues. Virtual meetings for a Harvest Strategy Capacity Building Seminar are scheduled for 8 June and 7 July 2022 in advance of the first Science Management Dialogue (SMD) which is scheduled for August 10-18, 2022. Workshop organizers hope that this proposed workshop will complement the other scheduled regional events and push forward key decisions for HS for SKJ and SP Albacore in 2022, and YFT and Bigeye by 2024. The goal is for the Philippines and Indonesia to review reference points and facilitate a consensus within the timelines.

A consortium of CSOs from both countries seek to work together to provide support and advocacy to respective governments to deliver outcomes. Therefore, the WWF Coral Triangle and MDPI aim to strengthen the work, through conducting a dialogue meeting between the governments of Philippines and Indonesia, to exchange knowledge, experience and lesson learned regarding the development and the implementation of HS and HCR in both countries.

#### **Meeting Objectives:**

- 1. Initiate a dialogue between Philippines and Indonesia to share knowledge and learnings on harvest strategies and control rules implemented in their archipelagic waters.
- 2. Identify key issues and challenges in the implementation of HS and HCR in both
- 3. Assess pathway towards supporting harvest strategies and control rules for Yellowfin tuna - include SKJ, Bigeye (SKJ in region 7 has reached limit ref points) in transboundary waters in the WCPFC convention area.
- 4. Assess a possible cooperation between two countries to advance the implementation of HS and HCR in the WCPO

- 1. Evaluate evidence behind decisions on reference points towards harvest strategies for YFT, SKJ, albacore and bigeye.
- 2. Form recommendations through shared experiences and interests (SSFs, archipelagic nature of the countries, reliance on tropical tunas for trade, livelihood and food security, majority of fishers are small-scale) to support sustainable management of tropical tunas in the WCPFC.
- 3. Develop a strategic partnership/mutual understanding and commitment to advance the HS and HCR in the region
