A Management Framework Determination for a sustainable balance in the Ban Don Bay,

Surat Thani Province

The management of the area from solving the problem of invasion of the land's public property in Bandon Bay occupying an area for aquaculture outside the area designated as a shellfish aquaculture area without permission from the conflict situation in Bandon Bay, Surat Thani Province. During May 2020, there has begun to expand and there has been an unrest situation, an illegal invasion of public areas by capitalists and influential people in the Bandon Bay, Surat Thani Province has been a problem accumulated for a long time and tends to expand into conflicts between local communities and local fishermen outside the area. By influential groups support each party due to the irresponsible and uncontrolled exploitation of natural resources in the sea. As a result, problems that have been accumulated for a long time have not been resolved concretely which the guidelines of the working group to solve the problem of invasion on public areas in Ban Don Bay, Surat Thani Province by the working group to solve the problem of invasion of public areas in Ban Don Bay, Surat Thani Province according to Surat Thani Provincial Order No. 3437/2563 dated June 12th, 2020 to solve the problem of the invasion of public areas in Ban Don Bay, Surat Thani Province. Because the illegal invasion of occupation sea areas and there is a feature that obstructs the navigation waterways or prevents others from accessing and being able to use the space shared by the people. On June 23rd, 2020, Thai-MECC has established the Joint Administration Division of Public Safety Operation and solves the invasion of public areas around Ban Don Bay, Surat Thani Province to direct, plan and supervise to maintain peace and order to prevent conflicts between cockle farmers and local fishermen for law enforcement and for the relevant agencies to enforce the law in the area to bring peace and order. It can be able to effectively take action against those who commit illegal acts and can return the public area around Bandon Bay, Surat Thani Province for people to use together equally with the Director of Thai-MECC Region 2 as the Director to the Public Safety Administration and solve the problem of invasion of public areas in the Bay of Ban Don Bay, Surat Thani Province took command with Thai-MECC and coordinated support from agencies, the Marine Department, the Department of Fisheries, the Department of Natural Resources and Environment, the Customs Department and the Marine Police Division.

From the implementation of the work plan of the working group to solve the problem of invasion of public areas in Bandon Bay Surat Thani Province of Thai-MECC, has a plan to return the public area in Ban Don Bay, Surat Thani Province during March 2021 for Surat Thani Province which the Department of Fisheries is the agency involved in the designation of public property areas of the land to determine the controlled aquaculture area, Sea shell category, according to Section 77 of the Fisheries Royal Decree B.E. 2558 and its amendment B.E. 2560 through the consideration of the Provincial Fisheries Committee. From the meeting of the Provincial Fisheries Committee on 29th June 2020, a subcommittee was set up to consider the sustainable solution of natural resource problems in Bandon Bay. As well as, from the meeting of the Sub-Committee to consider solving natural resource problems in Bandon Bay on July 29th, 2020, it was proposed to consider the action guidelines for consideration into 2 groups as the followings:

1. Management of navigation waterway channels and areas by the regional port office, Surat Thani branch to be the head team.

2. Guidelines for resource management in Bandon Bay by the Surat Thani Provincial Fisheries Office to be the head team.

The meeting of guidelines for resource management in the Bandon Bay by the Surat Thani Provincial Fisheries Office to be the head team has proposed to notify each district for action to inform fishermen groups to propose guidelines for area management and listen to opinions to propose to the subcommittee for further consideration.

The Provincial Fisheries Office would like to propose a framework for consideration for resource management in the Ban Don Bay, Surat Thani province to achieve a sustainable balance as follows:

1. Consider proposing government agencies in the integrated areas, in proposing guidelines for legal considerations that each agency enforces in the management of natural resources in the Bandon Bay by considering the guidelines possibility and legal barriers to local resource management, the department consists of.

- 1. Thai-MECC of Surat Thani Province
- 2. Provincial Fisheries Office of Surat Thani Province
- 3. Regional Port Office Surat Thani Branch
- 4. Office of Resources and Environment of Surat Thani Province
- 5. Surat Thani Provincial Local Office
- 6. Land office
- 7. Provincial Administration and other agencies etc.

Schedule a meeting to join the integration of agencies for plan to attend the meeting by there are officers presenting the laws of each unit with determine the guidelines for resource management to achieve sustainability, balance, and fairness for all parties.

2. Aquatic Resource Management Guidelines, to support proposals and to hear opinions from the community and local stakeholders for the cost-effective, balanced, and sustainable utilization of fishery resources.

2.1 Management of conservation areas or aquatic animal sanctuary under Section 56.

2.2 Area management for the utilization of aquatic resources to determine the cockle baby area. (Support for the birth of cockle baby in Ban Don Bay) by defining the fishing gear according to the form of the tool, fishing method, fishing area, size of fishing vessels that used for fishing operations and other conditions prohibiting the use of fishing in fisheries under section 71 (1).

2.3 Area management to define aquaculture areas (reduces the original area /adds new area) under section 77.

2.4 Area management of public property of the land for the common use of the Bandon Bay consists of 6 districts, 17 villages, namely:

1. Chaiya district, there are the coastal areas with 3 sub-districts including Ta-Krob Sub-district, Phum Riang Sub-district, and Lamet Sub-district.

2. Tha Chang District, there are the coastal area with 3 sub-districts including Tha Khei Sub-district, Tha Chang Sub-district and Khao Than Sub-district.

3. Phun Phin District, there is the coastal area with 1 sub-district including Lee Led Sub-district.

4. Mueang Surat Thani District, there are the coastal areas with 3 sub-districts including Bang Chana Sub-district, Khlong Chanak Sub-district, and Bang Kung Sub-district.

5. Kanchanadit District, there are the coastal areas with 5 sub-districts including Tha Thong Mai Sub-district, Takhianthong Sub-district, Ka-Dae Sub-district, Plaiwat Sub-district, and Tha Thong Sub-district.

6. Don Sak District, there are the coastal areas with 2 sub-districts including Chon Khram Subdistrict and Don Sak Sub-district.

3. Framework for solving the problem of illegal fishing gear in the Ban Don Bay by adhering to the law to enforce and the proposal to set up a Marine Fisheries Prevention and Suppression Unit, Ban Don Bay, which is an agency under the Department of Fisheries.

4. Integration of law enforcement agencies which affects the resources in the Bandon Bay.

Management guidelines to achieve a sustainable balance in the Bandon Bay, Surat Thani Province according to the resolution of the working group and a plan to implement a balanced and sustainable management, determinate guidelines have been presented to the Provincial Fisheries Committee at the meeting of the Surat Thani Provincial Fisheries Committee No. 2/2021 on Friday, July 23rd, 2021 to consider according to Agenda 4, Matters proposed to the meeting for consideration, subject 4.2 Subject 4.2 Considering management guidelines to achieve a sustainable balance in the Bandon Bay, Surat Thani Province according to the resolution of the working group and a plan to implement a balanced and sustainable management, determinate guidelines as follows:

Surat Thani Provincial Fisheries Office has determinate management guidelines to achieve a sustainable balance in the land's public property Bandon Bay, Surat Thani Province for conducting a public hearing of stakeholders in the area. After, Thai-MECC of Surat Thani Province has demolished the buildings. (Caring for the shellfish and homestays) and other structures in Muang District and Phunphin District are all out. So that people can use the area for fishing in the public areas in Ban Don Bay equally and legally as well as when the area is transferred to Surat Thani is completed. There are guidelines for doing this as the followings:

1) Actions to hearing to opinions in the Ban Don Bay.

- \square Basic information in the area
- □ The requirements of the stakeholders
- \square Related Laws
- □ Balanced and Sustainable Management

2) Information for actions to public hearing in Surat Thani.

2.1 Basic information in the area

2.1.1 Stationary fishing gears using such as type of shovel nets with wings or shrimp obstruct nets, type of Kram, Lham (bush pile for catching fish), and fishing house. From the presentation to the meeting for consideration by the Provincial Fisheries Committee proposed to the Provincial Fisheries Office as a secretary to consult the Legal Affairs Division, Department of Fisheries responding to discussions as follows; Characteristics of fishing gears and methods, type of shovel nets with wings are same type of set bag nets with wings or stow nets that there is characteristic as bag, the top of the nets is fixed. Fisheries by the methods of tides are blowing aquatic animals into the net bag, even with different names.

When a fishing gear in the type of shovel nets with wings as a prohibited from use or in possession for use in fishing under section 67 (1) and does not the exception of being able to use or have in possession for fishing under section 67 paragraph two and paragraph three of the Fisheries Royal Ordinance B.E. 2558. Therefore, fishing with such gears cannot be permitted.

2.1.2 Area Conditions

1) Aquaculture allowed area (primary) according to the Fisheries Royal Ordinance B.E.

2558.







Figure 4 Map showing areas suitable for Shellfish Farming in Ban Don Bay, Surat Thani Province

Figure 6 Map showing areas suitable for Mussels Farming in Ban Don Bay, Surat Thani Province Prepared by the Center for Information and Communication Technology




Figure 5 Map showing areas suitable for Oysters Farming in Ban Don Bay, Surat Thani Province







The results of the public hearing of stakeholders in 6 districts, 17 sub-districts on the balanced and sustainable management approach of Bandon Bay, Surat Thani Province. The stakeholders expressed comment and suggested guidelines for resources management in Bandon Bay, Surat Thani Province as follows:

- 1) the management of the area conservation or marine wildlife sanctuary under Section 56
- 2) the area management for the utilization of aquatic resources in order to determine the area for the cockle larvae (Support cockle larvae in Ban Don Bay) by specifying fishing gear, fishing method, fishing area, size of the fishing vessel, including other conditions that prohibit fishing under section 71 (1)
- 3) Area management to define areas for controlled aquaculture and shellfish farming (reduce the area /add new area) under section 77
- 4) Solving the problem of using illegal fishing gear by proposing to organize training and appointing fisheries official assistants and supporting local fisheries organizations to manage the fisheries resources in the area.
- 5) Select representatives of stakeholders who are in aquaculture groups and local fisheries groups including other stakeholder groups in the area and community leaders, 2 people per group (8 people per sub-district) to determine the area according to the needs of each sub-district in the overall public area management for each district and propose to the provincial fisheries committee for consideration in the following steps.

The Surat Thani Provincial Fisheries Office has prepared a public hearing meeting plan according to the project's operational guidelines for the 2nd public hearing meeting between March 28 and April 8, 2022. The results of the meeting are as follows.
