### Draft Terms of Reference

### Purpose


The purpose of the Working Group is to develop proposed elements to include in a PAF for Northern cod, for consideration by DFO. The elements of a PAF will be developed in accordance with DFO's <u>Fishery Decision-Making Framework Incorporating the Precautionary Approach</u>.

### Objective of the Working Group

The objective of the Working Group is to provide input to DFO on the following elements that will be included in the PAF for Northern Cod:

- Upper Stock Reference Point;
- Objectives;
- Management measures to support meeting the objectives (i.e. harvest decision rules);
- Method for monitoring progress towards objectives;
- Timeline for periodic review of the PAF to measure progress towards the objectives and determine if adjustments to the plan are required.
