Celtic Sea Whitefish Improvement Report

- To get fishers views of Celtic Sea Whitefish stocks, issues, and potential improvement options
- Options included TCMs such as mesh size, selectivity devices, closed areas, real time closures, minimum sizes
- Indications of improved Whiting in 2023
- Cod ongoing problem climate change











Celtic Sea Whitefish Improvement Report

- Closed areas initial support no evidence of benefit
- Effort displacement
- Fish not in expected numbers in closed areas
- Economic impact of Cod avoidance measures
- Support for further work on T90 mesh
- T90 more selective than SMP
- BIM upcoming trials on T90
- Increases in Bluefin, Boarfish, Hake, Red Mullet, Gurnard, Cuttlefish, Bream
