This meeting resulted in the following formulation: 1. RPP

Octopus focuses on types of octopus that are of high value and export commodities, in the WPPNRI areas as follows: 571, 572, 573, 711, 712, 713, 714, 715, 716.

2. From the issues that have been collected, priority issues for RPP management are formulated Octopus as follows: a.

Fish Resource Issues, consisting of:

i. Indications of degradation of the blue octopus fishery stock (**octopus cyanea**), especially in WPPNRI 573, 713, 714 and 716. ii. Limited scientific information and no regulation of catch size. b. Environmental Issues of Fish Resources, consisting of

i. Degradation of octopus habitat, especially coral reef ecosystems and

seagrass.

ii. Limited scientific information regarding unique/special habitats (life cycles)

octopus. c. Fisheries Socio-Economic Issues, consisting of:

i. Most octopus fishing boats have not been registered according to applicable laws and regulations. ii. Most octopus fishermen do not yet have Fisherman Skills Certification (SKN). iii. The ability of octopus fishermen to manage fish is still limited

finance. d.

Fisheries Governance Issues, consisting of:

i. The availability of octopus fisheries data for management is still limited besides the blue octopus (**octopus cyanea**).

ii. There is no **harvest strategy** for fisheries octopus.

iii. Involvement of key **stakeholders** in octopus fisheries is still low in the planning process and management actions for octopus fisheries

3. The objectives of octopus management are agreed to be 4 (four) management objectives, namely:

a. Ensure octopus resource stocks are maintained at sustainable levels; b. Ensure a healthy habitat and environment for resource sustainability

octopus;

c. Increasing the economic benefits of octopus fisheries for business actors fisheries, especially for the welfare of fishermen; And

d. Increase the active participation and compliance of fisheries stakeholders **in** realizing responsible octopus fisheries management.

This formulation has also been discussed and agreed upon by the participants who attended this offline **and** online **meeting**.
