### **Enforcement Summary Feb – Jul 2025**



#### **\*COMMERCIAL CRAB\***

A Senior Trooper followed up with a commercial crab skipper regarding his 2024 bay crab season. The skipper had turned in logbook pages for four commercial bay crab trips in September and October of 2024. There were no landings of crab for this vessel or skipper for bay crab. The skipper was contacted and admitted to taking some of the crab home and returning some of the crab to the bay because he could not find a market to purchase his small quantities of crab. Subject was informed that all commercial crab and fish must be sold to a wholesale dealer or through a limited fish seller permit. The subject was cited for failing to sell commercial crab to a wholesale fish dealer.

During an inspection of a commercial offload of Dungeness crab, a Trooper discovered undersized crab in two loads. Another Trooper and ODFW assisted with the inspections. One of the offloads contained 2.9% illegal crab. The fishing vessel captain was cited violation level as he was the one measuring the crab on that trip. The captain had hired a “driver”. The other fishing vessel contained 16% illegal crab. Both deckhands admitted they were told several times by the captain to be careful and stated they took sole responsibility for the undersized crab. Both deckhands were cited criminally for the illegal crab.

Marine Fisheries Team Members conducted a Guardian and Aircraft patrol from Cape Blanco to Newport focusing on commercial crab, marine reserves, shellfish sanitation and closed ATV beach areas. One vessel was found to have a string of gear with at least 5 buoys missing regular season tags. Another vessel was found to have more than 3 buoys on surface gear and surface line was longer than the maximum of 36 feet. Enforcement action is pending on boat vessels.

A Marine Fisheries Sergeant contacted a fisherman selling crab from his boat in Newport. The fisherman was associated with a wholesale dealer license but did not possess a buyer's license to allow him to make sales away from his dealer location which was in Grants Pass. The fisherman was also weighing crab from a scale that was not ODA certified. The fisherman was cited for No Buyer's license and warned for the scale.

MFT Troopers coastwide continue to focus on enforcement of the 14 day landing rule for the commercial crab fishery. Commercial crab fishermen are required to make a landing every 14 days. Pots that stray and get left out at sea can be hazards and contribute to whale entanglements. Ensuring fishermen are being diligent in tending gear is important to reduce the risk of derelict gear.

Members of the Marine Fisheries Team worked in the Port of Garibaldi to focus on enforcement of the 14 day landing rule. A Trooper contacted a Commercial fisherman, who operates 2 commercial fishing vessels during the Ocean Dungeness crab season, after it was discovered the fisherman failed to make a landing of Dungeness crab within the 14-day rule on multiple occasions with each boat. The fisherman was ultimately cited for **Leave Gear Set More Than 14 Days Without a Landing**. Two other fishermen were contacted and cited, who also only operated one boat, but also had either multiple occurrences where they violated the 14-day rule or had several months of time between landings.

A Trooper has contacted numerous vessels within the Newport Commercial Fishing fleet in regard to the 14 day landing rule for the ocean Dungeness crab fishery. All captains of the commercial vessels contacted have been warned or cited for the offense.

A Senior Trooper was contacted by ODFW regarding a vessel that made a landing of commercial crab on 5/1 without purchasing summer season tags. The vessel had come in on 4/29 with the last of the gear but had waited until 5/1 to land the crab. The value of the load was seized (\$10,378) and a check will be made out to ODFW. The skipper was cited for take/possession crab closed season and warned for multiple 14 day without crab landing violations.
