****COMMERCIAL CRAB****

Troopers and a F&W Sergeant, continued with an investigation into the use of unlawful commercial fishing gear. The previous week Troopers located and seized part of a string of commercial fishing gear using well more than the allowed amount of surface gear and extra buoys. It was later determined the gear was also using illegal “bio’s”. “Bio’s” refer to a strand of cotton put into pots that after time rot away leaving an escape hole in the pot. This allows for crab to escape the pot if it gets lost at sea. Troopers located more gear on two additional trips with illegal surface line and pulled some of those pots. Of the pots they pulled, the bio’s in these pots were legal. The captain was contacted when returning to his boat 16 days after his last landing. When questioned, the captain explained they were unaware there was a limit to the length of “end markers” on gear. The captain also said they only add the extra bio to the pots when the original bio was about to fall off. Enforcement action was taken on the captain of the vessel for Unlawful Use of Gear for Ocean Dungeness Crab – Surface Line, Unlawful Use of Gear for Ocean Dungeness Crab – Extra Buoy, Commercial Dungeness Crabbing with Inadequate Release Mechanism and Let Gear Set Longer than 14 days.

Troopers conducted an ocean patrol near Garibaldi. Multiple commercial Dungeness crab vessels were contacted. One commercial vessel was boarded and inspected. The same vessel’s crab pot was seized after being found within the boundaries of the Cape Falcon Marine Reserve back in December during a OSP GUARDIAN trip. The boat was also currently in violation of the 14-day landing rule. One crew member was also found to be commercial fishing while suspended following a citation from a 2025 charge of fishing without an individual commercial fishing license. The operator of the vessel was cited for Leave Gear Set More Than 14 Days Without a Landing and Commercial Fishing Closed Area. The crew member was cited for Commercial Fishing with a Suspended License.

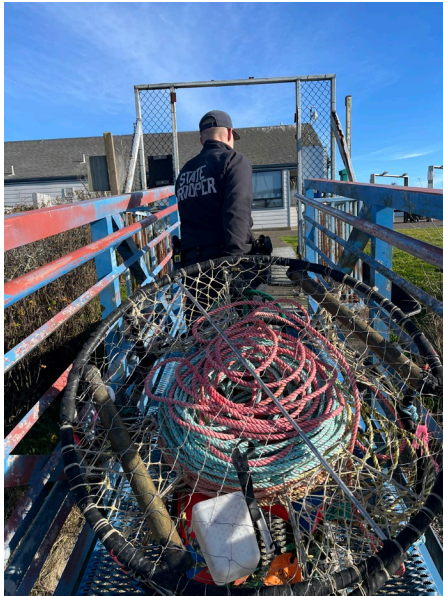
OREGON STATE POLICE – FISH & WILDLIFE COMMERCIAL CRAB ENFORCEMENT SUMMARY

Troopers investigated the sale of commercially harvested Dungeness crab at a local restaurant. Through investigation it was found a commercial fisherman had sold 51lbs of take home to a local restaurant for \$250 and then later sold 80lbs to the same restaurant for \$400 prior to renewing his Limited Fish Sellers Permit. The commercial fisherman was contacted and was criminally cited and released for No Limited Fish Seller Permit and Unlawful Sale of Commercial Food Fish.



A Trooper conducted follow-up on the report of a local Wholesale Fish Dealer who made a purchase of Dungeness Crab without a 2026 Wholesale Dealer License. Further investigation revealed the dealer forgot to purchase their 2026 license and immediately renewed it. The wholesale dealer was provided a warning for No Wholesale Fish Dealer License.

COMMERCIAL CRAB ENFORCEMENT SUMMARY**



A Senior Trooper followed up with a commercial crab skipper who had not turned in any Dungeness crab logbook pages for the season. The skipper was cited for Failing to Maintain/Submit Dungeness Crab Logbooks and additionally warned for Failing to Remove Crab Gear at the Close of Season. Over 40 of his crab pots were brought in by other vessels during the derelict gear program following the close of the season.

A Trooper followed up with a commercial crab captain who failed to turn in their logbooks after repeated warnings and citations for the same offense since 2016. The captain was again cited for Failing to Maintain/Submit Dungeness Crab Logbooks.

A Trooper contacted a commercial fisherman who had violated the 14-day landing rule during the commercial Dungeness crab fishing season. Commercial fisherman pursuing Dungeness crab in the Pacific Ocean are required to make a landing of crab every 14 days. The commercial fisherman was cited for Leave Gear Set More Than 14 Days Without a Landing.
